Saturday	June 14 th	-	10:00 am to 11:00 pm
Sunday	June 15 th	-	12:00 noon to 5:00 pm

Events and Attractions include: Bands (headliner not yet named), Queen Pageant, Free Style Motocross, Bull Riding, Horse show, 4-H Events, Horticulture & Livestock Shows, ATV Rodeo, Moto-Cross Races, Family Consumer Sciences, Community Service Organizations, and much, more.

Our contract with the Carnival provides them certain food exclusives. Call with questions or clarification for exclusions for the 2008 Fair.

All exhibitors/vendors must pay the exhibitor/vendor fee before they can set up, and locations are on a first come, first served basis. Early registrations have priority. **No exhibitor/vendor can set up until checked in by our staff.** All checks need to be payable to the Pulaski County Regional Fair. Please attach your check to the Exhibitor/Vendor Registration Form.

You must set up between the hours of 12 pm to 3:30 pm on Thursday, June 12th, 12 pm to 3 pm on Friday, June 13th, 8 am to 10 am on Saturday, June 14th and 10 am to 12 pm on Sunday, June 15th. **All vehicles must be removed from the area before 3:00 pm on Thursday, June 12th and by 3:00 pm on Friday, June 13th, by 9:00 am on Saturday, June 14th and by 11:00 am on Sunday, June 15th.**

Exhibitors/Vendors must stay set up throughout the fair, unless there is an emergency. **No vendor vehicle traffic is allowed during fair hours.** A Designated Parking Area is available. If you need assistance during Fair hours, the Fair staff has shuttle capability for small equipment and supplies.

We are charging to get into this event, and **all exhibitors/vendors and their staffs are required to have an armband.** Two armbands for each day are provided with the booth rental; *any additional attendees must purchase an arm band for the day(s) they attend.

Not for profit organizations will not be charged for an exhibitor booth space. However, they are required to provide giveaway items or some type of free game for kids. Booth staffs must have arm bands.
